ROAD TRAFFIC REGULATION ACT 1984

THE WINCHESTER CITY COUNCIL (VARIOUS ROADS, WICKHAM) (PARKING PLACES AND RESTRICTION OF WAITING) ORDER 2009 (Variation No.2) Order 2020.

Winchester City Council acting on behalf of Hampshire County Council in exercise of its powers and duties under Sections 1, 2, 4, 32, 35, 45, 46, 49, 51, 53 and 122(1) and (2) and Part IV of Schedule 9 to the Act as amended by the Road Traffic Regulation (Parking) Act 1986 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order :-

1. In this order “the Act” means the Road Traffic Regulation Act 1984; and the “Principal Order “ means “The Hampshire (Various Roads, Wickham) (Parking Places and Restriction of Waiting) Order, 2009” as amended.
2. The Principal Order shall have effect in that the items specified in Schedule I and II of this Order shall be deleted from Schedule I and Schedule IV of the Principal Order.
3. The Principal Order shall have effect as though the items specified in Schedule III of this Order shall be inserted in Schedule I and the items specified in Schedule IV of this Order shall be inserted in Schedule IV.
4. The Principal Order shall have effect as though a new Article 2.1 is added:
“2.1 Save as provided in Articles 3 and 4 of this order no person shall, except upon the direction or with the permission of a police constable in uniform or traffic warden, cause or permit any vehicle to stop on the school entrance Monday to Friday (inclusive) between 8am-9am and 3pm-4pm as specified in Schedule V to this Order.”
5. The Principal Order shall have effect as though the items specified in Schedule V to this Order, No Stopping on School Entrance between 8am-9am and 3pm and 4pm are added to the new Schedule V described in the new Article 2.1.
6. The Hampshire (Various Roads, Wickham) (Restriction of Waiting) Order 1993 as amended is hereby revoked.
7. This Order shall come into operation on _____ 2020 and may be cited as The Hampshire (Various Roads, Wickham) (Parking Places and Restriction of Waiting) Order, 2009 (Variation No. 2) Order 2020
