

WINCHESTER CITY COUNCIL – TRAFFIC REGULATION ORDER PROPOSAL

THE HAMPSHIRE (VARIOUS ROADS, BISHOPS WALTHAM) (RESTRICTION OF WAITING) ORDER 1985 (VARIATION NO.3) ORDER 2021

Winchester City Council as agents for Hampshire County Council proposes to make the above road traffic regulation order. The proposed Order is required to improve visibility and road safety.

The effect of this order will be to introduce no waiting restrictions at two locations in Bishops Waltham as described below:

1. The junction of Martin Street and Victoria Road.

No waiting at any time (double yellow lines) is proposed on both sides of Martin Street at its junction with Victoria Road (on the south-east side for approximately 17m and on the north-west side for approximately 15m), and on Victoria Road (on the southern side from approximately 8 metres north-west of its junction with Martin Street to approximately 11 metres south-east of that junction). There is a development of approximately 60 dwellings approved on Martin Street. The developer has already installed a layby to ensure better sight lines for traffic entering and exiting this junction. The proposed restriction will further improve visibility at this junction which will have increased traffic movements when the development is built out and occupied.

2. Coppice Hill

No waiting at any time (double yellow lines) is proposed on the south-west side of Coppice Hill extending either side of its junction with Saxby Road for approximately 31 metres south-east of the junction and approximately 33 metres north-west of the junction. This is to improve visibility splays at this junction which are restricted due to parked cars. The junction of Saxby Road and Coppice Hill is located within close proximity to a roundabout and therefore good visibility while using this junction would improve the safety of vehicles exiting Saxby Road.
